WORKS IN PROGRESS

I am currently working on, *Avenging Christ in Medieval England*, a monograph that traces the evolution of medieval narratives that relate the Roman destruction of Jerusalem and articulates the cultural and religious uses of these stories in medieval England. These narratives, which appeared in a wide variety of media and genres, anachronistically imagined the destruction of Jerusalem and its Jewish inhabitants as retribution for the crucifixion of Christ, when in fact the siege occurred centuries before the rule of Constantine and the conversion of the Roman Empire to Christianity. I am especially interested in the proliferation of the narratives in late medieval England following the Edict of Expulsion of 1290, after which no Jews were openly living in England. I argue that the narratives continued to target Judaism and Jewish people, even in their physical absence, in an effort to reconcile theological and devotional anxieties over the role of Judaism as the precursor and source of Christianity, and that the narratives' successful targeting and destruction of Jerusalem served as a wish fulfillment, a sort of surrogate victory in an era in which English armies failed repeatedly to recapture Jerusalem during the Crusades.

CODICOLOGICAL DESCRIPTIONS

I have been commissioned by the *Roman de la Rose* Digital Library and e-codices: Virtual Manuscript Library of Switzerland to write codicological descriptions of medieval manuscripts they feature, fourteen of which have been published on these sites thus far. Each description is based on in-person consultation of the book and research on its origins and provenance and includes detailed reports on the material quality and construction of the book, the layout of text and images, scribal work, decoration, binding, and history.
